Since 1998, he has been a Senior Lecturer at the University of Córdoba (5 Quinquennia). Secretary of the Córdoba section of the Institute of Criminology from 2006 to 2012. Substitute Judge at the Provincial Court of Córdoba from 2009 to 2015. Member of the Works Council for the teaching and research staff (PDI) at the University of Córdoba since 2019 (secretary of this body since 2023). He is the author of various textbooks, monographs, book chapters, and articles published in journals of the discipline on Criminal Law topics, covering both the General and Special Parts (1 Sexennium).
