### Part B. CV SUMMARY (max. 3500 characters, including spaces)

My research career focuses on writers from the Pacific, particularly New Zealand. It began with my PhD thesis on Mansfield (2003). I have taken part in conferences on New Zealand: 'Katherine Mansfield Conference' in London (2008), and the International Conferences of the New Zealand Studies Association in Vienna (2015), Strasbourg (2017) and Athens (2019). I have published in the most prestigious journals of New Zealand and Australian Literature: Antipodes, Journal of New Zealand and Pacific Studies, Australian Literary Studies, Meanjin, JASAL. I have become a figure of international reference, as testified by my central role in the foundation of the Katherine Mansfield Society (2008) and my active participation in the New Zealand Studies Association. My expertise and commitment led to the New Zealand Studies Association to their formal invitation in January 2018 for me to become a full member of its council and a member of the editorial board of their Journal of New Zealand and Pacific Studies. Nicholas Birns, editor of Antipodes and specialist in Australian literature, refers to me, together with Susan Ballyn, as 'un destacado académico en Literatura Australiana



**residente en España**' in his article 'Australia más cerca' (trans. F. Revuelta: *El País* 7/05/2011), mainly as a result of my research on Patrick White Award writer Carmel Bird.

As a result of my participation in the research projects detailed in C.2, I have written articles and book chapters published in publishing houses and journals of high prestige. My research interests focus on New Zealand (and Australian) literature, using post-phenomenological communitarian theories, always from the perspective of gender. Ethnicity and postcolonialism are central issues particularly in my research on Carmel Bird, Witi Ihimaera and Sia Figiel.

I have participated in more than 50 international conferences, among others, Paris, Vienna, London, Prague, Budapest, Lisbon, Strasbourg, or Athens. I have been invited to deliver 6 plenary lectures, one of them as a result of my expertise in communitarian theory, resulting from the I+D projects: *I Congreso Internacional Políticas de la Literatura: Un diálogo con Jacques Ranciére* (University of Granada). I have published 50 articles in academic journals, 30 books chapters, 4 monographs as author or co-author, 5 volumes as editor, 5 methodological volumes or textbooks as co- author and 8 conference proceedings.
